

## BULK WATER OR METERED HYDRANT PERMIT APPLICATION

Permits must be completed and returned to the Fitchburg Utilities office located at: 5520 Lacy Rd. **Utility Office**: 608-270-4271 **Fax**: 608-270-4212 **Superintendent**: 608-729-1730

Per rate schedule BW-1: Permit Fee - \$35.00 plus \$3.62 per 1,000 gallons

Hydrant wrench deposit - \$30.00

Meter Charge - \$15.00(3/4") or \$72.00(2 1/4")

## Call Utility Office when project is completed to avoid paying any penalties and/or fines!

## Check one:

□ **BULK WATER PERMIT** - This permit includes bulk water supplied to fill tank trucks from the water system. All water shall be metered or tanker size must be known.

- 1. Bulk haulers must load at the Fire Department located at 5791 Lacy Rd. 278-2980. (Water fill connection is located in back of the Fire Department)
  - **OR** at the small single nozzle fill hydrant located at the corner of Lacy Rd and Jones Farm Rd.
  - It is painted blue with a large sign in front of it. PLEASE OPEN 4 TURNS ONLY.
- 2. Bulk haulers must provide own  $2\frac{1}{2}$ " standard fire hydrant hose connection from the fire hydrant to the tanker and wrench.
- 3. Return your permit when project is completed with total amount of water used.

☐ METERED HYDRANT PERMI	<b>r</b> - This permit shall allow the use of water at a construction site through a
metered fire hydrant connection.	The meter and connection shall be provided and installed by Utility personnel
only.	

- 1. Hydrant must be fully opened. Use gate valve to throttle flow. Shut off hydrant after use each day.
- 2. Contractor shall notify the Utility office as soon as the meter is no longer needed.
- 3. Location of meter to be set. -

24 hr. notice must be given prior to meter being set.
